If the repayment plan is the sale of more than one property then you will need to complete a form for each property.

By sending this form you agree to TSB arranging an Automated Valuation Model (AVM) valuation of the property and to carry out any Land Registry searches where required.

NB. If the AVM fails to sufficiently value the other property an alternative repayment vehicle will be required or the customer will be required to instruct a full valuation of the other property (at their own cost), through TSB's nominated valuers.
